

## TUITION GUIDELINES FOR THE ACADEMIC YEAR 2024/2025

## International Students who began their studies at RIT Croatia in the 2024/2025 academic year

- If your semester tuition payment is not received on or before the payment due date, tuition will be increased by 100,00€, you will be removed from all class lists, and will not be allowed to attend classes.
- All students with outstanding dues will not be allowed to register until all dues have been settled.
- There is an option to pay semester tuition in 5 monthly installments based on the payment plan. In case of choosing the payment plan option the semester tuition is increased by € 150,00 per semester. Each installment amounts to 1/5 of the tuition amount due for the semester as stated above.

\*Payment plan request need to be signed and submitted to the Finance Office. To request a form and approval for a Payment plan, please contact our Finance office at <u>finance@croatia.rit.edu</u>.

In case of unpaid installments, or late payments, the payment plan can be suspended and signer is obligated to settle all remaining dues immediately and payment plan option might not be available in the following semesters.

\*\*Credit card payments (Visa, Maestro, Master Card) are available for full semester payments only. Please
note that the price for credit card payments is increased by € 50,00 than wire transfer payment.

## Guidelines for determining per-credit tuition for students taking less than 12 or more than 17 credits:

- Tuition for the entire academic year 2024/2025 is 8.200,00 EUR for 12-17 per semester credits.
- Tuition for 1 semester of the academic year 2024/2025 is 4.100,00 EUR for 12-17 semester credits.
- Price for 1 semester credit is 341,67 EUR.
- Tuition calculation details:
  - 12-17 semester credits = full tuition
  - Less than 12 semester credits = underload, students pay per every semester credit registered (price for 1 semester credit x total number of credits registered)
  - More than 17 semester credits = overload, students pay full tuition + overload credits (full semester tuition + price for 1 credit x total number of registered credits over 17).
